- 編製統計數據和證券持有人資料;
- 披露有關資料以便就權益索償;及
- 與上述有關的任何其他附帶或相關用途及/或使本公司及香港股份過戶登記分處能履行對證券持有人及/或監管機構承擔的責任及/或證券持有人不時同意的任何其他目的。

#### 3. 轉交個人資料

本公司及其香港股份過戶登記分處所持有關證券持有人的個人資料將會保密,但本公司及香港股份過戶登記分處可以在達到上述任何用途之必要情況下,向下列任何人士披露或轉交(無論在香港境內或境外)有關個人資料:

- 本公司或其委任的代理人,例如財務顧問、收款銀行和海外股份過戶登記總處;
- (如證券申請人要求將證券存入中央結算 系統)香港結算或香港結算代理人,彼 等將會就中央結算系統的運作使用有關 個人資料;
- 向本公司或香港股份過戶登記分處提供 與其各自業務營運有關的行政、電訊、 電腦、付款或其他服務的任何代理人、 承包商或第三方服務供應商;
- 聯交所、證監會及任何其他法定監管機關或政府部門或遵照其他法例、規則或法規;及

#### 4. 個人資料的保留
